Outline of the Act Partially Amending the Act on the Compensation of Judges and the Act on the Salaries of Public Prosecutors

Outline of the Act

In accordance with the revision of the salaries of general government officials, the compensation and monthly salaries of judges and public prosecutors will be revised.

Contents of the Amendments

1. Revision of the Monthly Salary [Will be Revised from April 2023]

In accordance with the revision of the salaries of general government officials, the compensation and monthly salaries of judges and public prosecutors will be increased by 1,500 - 7,700 Yen.

 - · Assistant Judge Category 1 12
 - ·Summary Court Judge Category 5 17

Act on the Salaries of Public Prosecutors: Appended Table (Related to Article 2) and Supplementary Provisions Article 3 will be revised.
