

外国為替及び外国貿易法第十六条第一項又は第三項の規定に基づく財務大臣の許可を受けなければならない支払等を指定する件

Payments Requiring Prior Permission of the Minister of Finance Pursuant to Article 16, paragraph (1) or (3) of the Foreign Exchange and Foreign Trade Act.

外国為替令（昭和五十五年政令第二百六十号）第六条第一項の規定に基づき、外国為替及び外国貿易法（昭和二十四年法律第二百二十八号。以下「法」という。）第十六条第一項又は第三項の規定に基づく財務大臣の許可を受けなければならない支払等（支払又は支払の受領をいう。以下同じ。）を次のように指定し、平成十年四月一日から適用し、大蔵大臣の許可を受けなければならない支払又は支払の受領及び支払手段等の輸出又は輸入を指定する件（昭和五十五年十一月大蔵省告示第百十七号）は、平成十年三月三十一日限り、廃止する。

Pursuant to Article 6, paragraph (1) of the Foreign Exchange Order (Cabinet Order No.260 of 1980), payments, etc. (meaning making or receiving payments; the same applies hereinafter) that require permission from the Minister of Finance pursuant to Article 16, paragraph (1) or paragraph (3) of the Foreign Exchange and Foreign Trade Act (Act No.228 of 1949; hereinafter referred to as "the Act") are hereby designated as follows, and this designation applies as of April 1, 1998. The "Designation of Payments made or received that Require Permission from the Minister of Finance, and the Export or Import of a Means of Payment, Prescribed Security, or Precious Metal" (Ministry of Finance Public Notice No.117 of November 1980) is repealed as of March 31,1998.
