

## Outline of the Act Partially Amending the Act on the Compensation of Judges and the Act on the Salaries of Public Prosecutors

### Outline of the Act

The compensation and monthly salaries of judges and public prosecutors to be amended in accordance with the amendment of the salaries of general government officials

### Content of the Amendments

#### 1 Increase based on the difference with private sector salaries [Amended from April 2024]

Act on Compensation of Judges: Appended Table (Re: Article 2) and Article 15  
Act on the Salaries of Public Prosecutors: Appended Table (Re: Article 2) and Supplementary Provisions Article 3

The monthly compensation and salaries for judges and public prosecutors will be increased by 5,300 yen up to 22,000 yen per month in accordance with the salary amendment for general government employees based on the difference with private sector salaries.

(1) The following judges and public prosecutors whose salaries are paid in the same manner as for employees to whom the Professional Administrative Service Salary Schedule (1) apply:

- Assistant Judge Grade 1 through 12 and Summary Court Judge Grade 5 through 17
- Public Prosecutor Grade 9 through 20 and Assistant Public Prosecutor Grade 3 through 17

1.27% - 9.09%

(2) The following judges and public prosecutors whose salaries are paid in the same manner as for employees to whom the Designated Service Salary Schedule apply:

- Judge Grade 1 through 8 and Special Category Summary Court Judge Grade 1 through 4
- Public Prosecutor Grade 1 through 8 and Special Category Assistant Public Prosecutor Grade 1 and 2

1.06% through 1.54%

(3) The following judges and public prosecutors whose salaries are equivalent to those of government officials with special capacity:

- Chief Justice of the Supreme Court, Justice of the Supreme Court, and High Court President
- Prosecutor General, Deputy Prosecutor General, and Superintending Prosecutor

1.08% - 1.15%

(Reference) Special salary (bonus) will be amended as follows, in the same manner as for general government employees

- Persons equivalent to general government officials: From 4.50 months to 4.60 months (+ 0. 10 months) annually
- Persons equivalent to designated service officials: From 3.40 months to 3.45 months (+ 0. 05 months) annually
- Persons equivalent to special capacity officials: From 3.40 months to 3.45 months (+ 0. 05 months) annually

#### 2 Amendments due to the improvement of the salary system [To be amended from April 2025]

Act on Compensation of Judges: Appended Table (Re: Article 2)  
Act on the Salaries of Public Prosecutors: Appended Table (Re: Article 2)

The compensation and monthly salary of judges and prosecutors equivalent to the salaries of employees to which the Administrative Service Salary Schedule (1) applies are to be amended in response to the salary amendment of general government employees which is in accordance with the changes in society and public services.

- Assistant Judge Grade 1 through 12 and Summary Court Judge Grade 5 through 17
- Public Prosecutor Grade 9 through 20 and Assistant Public Prosecutor Grade 3 through 16

## 裁判官の報酬等に関する法律の一部を改正する法律及び 検察官の俸給等に関する法律の一部を改正する法律の概要

### 法律の概要

一般の政府職員の給与改定に準じて、裁判官・検察官の報酬・俸給月額について改定を行うもの

### 改定の内容

#### 1 民間給与との較差等に基づく引上げ【令和6年4月から改定】

裁判官報酬法:別表(第2条関係)・第15条  
検察官俸給法:別表(第2条関係)・附則第3条

民間給与との較差等に基づく一般の政府職員の給与改定に準じて、裁判官・検察官の報酬・俸給月額を5,300円～22,000円引上げ

##### (1) 行政職俸給表(一)の適用を受ける職員の俸給に準ずる裁判官・検察官

- ・判事補1号～12号、簡易裁判所判事5号～17号
- ・検事9号～20号、副検事3号～17号 1.27%～9.09%

##### (2) 指定職俸給表の適用を受ける職員の俸給に準ずる裁判官・検察官

- ・判事1号～8号、簡易裁判所判事特号、1号～4号
- ・検事1号～8号、副検事特号、1号、2号 1.06%～1.54%

##### (3) 特別職の職員の俸給に準ずる裁判官・検察官

- ・最高裁判所長官、最高裁判所判事、高等裁判所長官
- ・検事総長、次長検事、検事長 1.08%～1.15%

(参考)特別給(ボーナス)は、一般の政府職員と同様に次のとおり改定予定

- ・一般職相当 年間 4.50月分→4.60月分(+0.10月分)
- ・指定職相当 年間 3.40月分→3.45月分(+0.05月分)
- ・特別職相当 年間 3.40月分→3.45月分(+0.05月分)

#### 2 給与制度の整備に伴う改定【令和7年4月から改定】

裁判官報酬法:別表(第2条関係)  
検察官俸給法:別表(第2条関係)

社会と公務の変化に応じた一般の政府職員の給与改定に対応して、行政職俸給表(一)の適用を受ける職員の俸給に準ずる裁判官・検察官の報酬・俸給月額を改定

- ・判事補1号～12号、簡易裁判所判事5号～17号
- ・検事9号～20号、副検事3号～16号
