


# Outline of the Act on Support for Reconstructing Livelihoods of Disaster Victims

## 1. Purpose of the system

The purpose is to support the reconstruction of livelihoods of persons who have suffered substantial damage to the foundation of their livelihoods due to natural disasters, by providing them support grants for reconstructing their livelihoods with the use of a fund contributed by prefectures from the perspective of mutual support, thereby helping to stabilize the livelihoods of residents and promote the prompt recovery of affected areas



## 2. Application requirements

- (1) Municipalities that meet application criteria 1 or 2 of the Disaster Relief Act
- (2) Municipalities with 10 or more completely destroyed households
- (3) Prefectures with 100 or more completely destroyed households
- (4) Municipalities within prefectures under (1) or (2) with five or more completely destroyed households (Limited to areas with a population of less than 100,000)
- (5) Municipalities adjacent to areas (1) through (3) with five or more completely destroyed households (Limited to areas with a population of less than 100,000)
- (6) If there are two or more prefectures listed in (1) through (3),
  - Municipalities with two or more completely destroyed households (limited to those with a population of less than 50,000)
  - Municipalities with five or more completely destroyed households (limited to those with a population of less than 100,000)

## 3. Amount of support grant

(For households with only one person, the amount is 3/4 of the amount in each applicable column.)

## 4. Application for support grant

(Application period) Basic support grant: Within 13 months from the date of the disaster

Additional support grant: Within 37 months from the date of the disaster

(Application contact point) Municipalities

(Documents to be attached at the time of application) Basic support grant: Disaster victim certificate, resident record, etc.

Additional support grant: Contracts (purchase of a home, rent, etc.) etc.


# 被災者生活再建支援制度の概要

## 1. 制度の趣旨

自然災害によりその生活基盤に著しい被害を受けた者に対し、都道府県が相互扶助の観点から拠出した基金を活用して被災者生活再建支援金を支給することにより、その生活の再建を支援し、もって住民の生活の安定と被災地の速やかな復興に資することを目的とする。

支援法適用

## 2. 適用要件

- ① 災害救助法の適用基準のうち1号又は2号を満たす市町村
- ② 全壊世帯が10世帯以上の市町村
- ③ 全壊世帯が100世帯以上の都道府県
- ④ ①又は②の都道府県内で、全壊世帯が5世帯以上の市町村（人口10万人未満に限る）
- ⑤ ①から③の区域に隣接し、全壊世帯が5世帯以上の市町村（人口10万人未満に限る）
- ⑥ ①から③の都道府県が2以上ある場合、
  - ・全壊世帯が2世帯以上の市町村（人口5万人未満に限る）
  - ・全壊世帯が5世帯以上の市町村（人口10万人未満に限る）

## 3. 支援金の支給額

（世帯人数が1人の場合は、各該当欄の金額の3/4の額）

## 4. 支援金の支給申請

（申請窓口） 市町村

（申請時の添付書面） 基礎支援金： 署災証明書、住民票 等  
加算支援金： 契約書(住宅の購入、賃借等) 等

（申請期間）基礎支援金： 災害発生日から13月以内

加算支援金： 災害発生日から37月以内
